Chief of Staff of the Army Gen. James McConville, Army War College Class of a 2002 Army War College graduate, spoke to a hybrid audience in Bliss Hall, as part of Army Leader Day, Oct. 27.

For McConville, "People First" is a philosophy centered on getting the right people in the right jobs at the right time and building organizations with cohesive units where members are cared for and respected so we can have a better Army. He included good and bad examples and lessons learned from his career.

Multiple times, McConville emphasized that readiness and modernization

endure as crucial components to U.S. Army success; it is what sets our Army apart from all others, he said.

He highlighted several leadership imperatives at the strategic level, enriched with anecdotes and observations: character, understanding interests, unity of effort, relationships with media and Congress, talent management & mentoring, and situational awareness of how things get done in the complex environment of the Pentagon.

Following his comments, McConville spent time taking students' questions, ranging his thoughts on how to care for those you lead to his opinion on Afghanistan and his perspective on the strategic objectives in the Arctic region.
